## Re: 3291 Kingston Road and 2 & 4 Windy Ridge Development Application

Dear Councillor Crawford,

For over 3 years, The Cliffcrest Scarborough Village South West Residents Association (CSVSWRA), has been very involved, and in continual contact with you and your office regarding the proposed development at 3291 Kingston Road and 2 & 4 Windy Ridge. As you and your office are aware, our concerns regarding this proposed development resulted in the CSVSWRA, both seeking and achieving 'Party Status' for the upcoming hearing at the Ontario Land Tribunal (O.L.T.B.). Having knowledge of the foregoing, we find it quite distressing that the first time your office informed us about the Request for Direction Report for this development being put on the July 19th, 2023 agenda of Scarborough Council was on July 17th, 2023.

## CSVSWRA as a 'Party' did not have the opportunity to participate in discussions with the City prior to the submission of the Request for Direction Report presented to Council.

**Now I am aware that** City Legal has indicated to your Chief of Staff that they have made multiple attempts to meet with our legal counsel over the past month; however, I am emphatically stating that this is simply untrue. In fact, it is our legal counsel and expert who have been blocked and rebuffed by City Legal and City Planning. The only responses we did get from City Legal were as follows:

A) a request to meet sent after regular business hours with invitations to meet first thing the next morning. Suffice to say the lack of lead time prohibited any one from attending a suggested a.m. meeting.

B) a recent e-mail where I acknowledge City Legal did give us a full day's notice. Unfortunately, this was the day that the Direction Report was to be presented at City Council.

We understand that City legal and City Planning are independent and acting for the City, but we fail to understand why two of the parties to this proposal have been in discussions, while we 'holding party status were ignored. While staff may not want to talk to the public, it is odd they did not feel they should speak with our professionals to both advise us of the City's concerns and to understand our concerns. We fail to understand how this course of action assists in any attempts to come to a fair and reasonable resolution to at least some of the issues prior to the hearing.

CSVSWRA Legal and Planning team collaborated with the Applicant who was open to working with us to review the massing of the building. In May CSVSWRA sent back a list of items that were to be clarified with the Applicant. A follow up to the Applicant on July 14<sup>th</sup> with regards to these outstanding items is how we first learned that the Direction Report being on the July 19<sup>th</sup> City Council.

Please note that the Report for action dated July 4, 2023 for this appeal states:

The Tribunal had originally scheduled a third case management conference on June 2, 2023, but it was later adjourned to September 14, 2023 to permit the City to seek instructions on the proposed development and allow further discussion with the parties and participants.

CSVSWRA has been engaged with you and your office for more than 3 years prior to this OLT Appeal in good faith and following your direction and city plannings. I am happy to provide documentation of CSVSWRA many attempts to bring attention to this specific development and other surrounding proposals that impact the BIG picture issues. Our calls for attention and action for detailed combined impact studies have for the most part been ignored. (Document produced with a list of 101 concerns for this particular development, Secondary Plan requested back in 2021 with many follow ups, cumulative impact concerns raised with Toronto Water, TRCA and more.). When you and your staff did decide to meet with us it seems now you have been stalling for time. When will you and the city prioritize and take the necessary action to address the concerns of residents?

Kindly provide an update I can share with our membership.
