LCH Developments has appealed the condo application at 3291 Kingston Rd and 2 & 4 Windy Ridge Dr. to the Ontario Land Tribunal

Cliffcrest Scarborough Village SW Residents Association (CSVSWRA) is NOT against development. The Community RA advocates for appropriately sized developments. Some concerns about the proposal are:

- The design & size of the 11 storey building with 309 units is an incursion into the surrounding established low rise neighbourhood ignoring need for more family size **affordable** units
- Eighty mature trees will be destroyed. The **environmental impact** on nearby Doris McCarthy trail and migratory birds has been ignored.
- Incomplete studies where condominium projects are assessed on a site-by-site basis ignoring cumulative impacts of two other large scale Condos proposed within 2 blocks.
- Traffic Report was done on July 31st during covid, we need unbiased reports to show full impact.
- Approval of this building will set a precedent likely to be repeated along Kingston Road, throughout Cliffcrest and Scarborough Village.


