NOTICE OF PUBLIC MEETING

To be held by the Scarborough community Council (Under the *Planning Act*)

Request to Amend the Official Plan Application Number 22 206341 ESC 20 OZ and to amend the Zoning By-law Application Number 21 165800 ESC 20 OZ

PROPOSAL

The application to amend the Official Plan proposes to redesignate 67 Elfreda Boulevard from *Neighbourhoods* to *Mixed Use Areas*.

The application to amend the Zoning By-law proposes to establish an appropriate zoning category and development standards to permit the redevelopment of the subject lands with a thirteen (13) storey mixeduse development comprising 429 residential apartment units and approximately 400 square metres of atgrade commercial uses for the lands municipally addressed as 3431 to 3449 St. Clair Avenue East and 67 Elfreda Boulevard. A total of 242 vehicular parking spaces would be provided including 219 spaces for residents on three underground parking levels and 23 spaces for residential visitors and the retail commercial uses. A total of 324 bicycle parking spaces will also be provided. The proposed development represents a Floor Space Index ("FSI") density of 6.0 times the site area, and a building coverage of 68 percent of the site area.

If you wish to be notified of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk Attention: Administrator at the address, fax number or e-mail set out above.

Official Plan and Zoning By-law Amendment

Appeal: If a person or public body does not make oral submission at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted or refused and the Zoning By-Law Amendment is passed or refused, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land



Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website.
